NOTICE OF IMPOUNDMENT OF ESTRAY

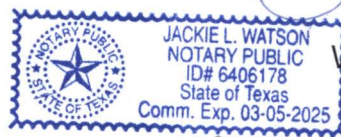

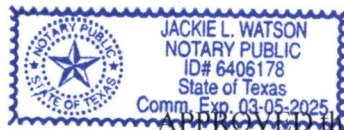
